


- Need commitment from whole government

SIGNIFICANT FINDINGS

- Incomplete regulation, low commitment of local government and low budget allocation
- 2. The uncertainty management and maintenance obligation to the built infrastructure.
- Monitoring and follow-up for problems have not adequately implemented



RECOMMENDATION

- Complete the regulations, update the guidelines based on the latest regulations and conditions, formulate policies of coordination, participation, collaboration among stakeholders and commitment of local government.
- Formulate policies of management and maintenance of the built infrastructure to support program sustainability.
- Formulate policies related to monitoring and evaluation of the community-based drinking water and domestic wastewater program.

CONCLUSION

BPK concludes that if the problem is not resolved immediately it will affect the threat of national targets that have been set in the provision of community-based drinking water and domestic wastewater infrastructure


A cross-sectoral approach in encouraging increase investment and compiling a comprehensive strategic plan for sanitation development

ZISWAF

ZISWAF can be used for the provision of drinking water and sanitation facilities in the community. MUI has issued it's Fatwa for the utilization of these ZISWAF funds

Wastewater Grants

Innovation of funding mechanisms to help local governments increase sanitary condition. This grant is reimbursement from APBD allocations
